



# 2023-2024 REGISTRATION CONTRACT

Complete and submit the registration contract to the business office with the registration fee by the appropriate date to ensure your child's enrollment for the 2023-2024 school year.

**PRIORITY REGISTRATION** for currently enrolled students is February 1-28, 2023  
\$350 per student for currently enrolled K5-11 students during Priority Registration  
\$450 for currently enrolled K4 students during Priority Registration

**OPEN REGISTRATION** for new families begins March 1, 2023  
\$450 per student for all students, new and current, during Open Registration

# MANDATORY FEES

## REGISTRATION FEE

- \$350 during Priority Registration for current families (K5-11)
- \$450 for current K4 during Priority Registration
- \$450 for ALL families beginning March 1, 2023
- If accounts are past due on April 30, 2023, registration fees will be applied to past due balances and registration will be revoked.

## MANDATORY FUNDRAISER

- \$500 per family due by December 1, 2023
- Enters you into five lottery-style drawings for \$1,000 each.
- Your ticket will be mailed in June 2023 and should be returned with payment.

## INTERNATIONAL STUDENTS

- \$700 Administrative Fee
- \$350 Administrative Fee if beginning after January 1, 2024

## STUDENTS ENROLLING AFTER JANUARY 1, 2024

- \$225 Registration Fee
- \$250 Mandatory Fundraiser

## GRADE-LEVEL DUES/FEES

Grade-level fees cover academic consumables, novel fees, science lab fees, elective fees, etc. Further explanation of fees can be found in the Student Handbook on Bulloch Academy's website. Fees for K-10 are due October 1st. Fees for 11th and 12th are assessed in two equal payments and are due October 1st and February 1st.

## RULES & REGULATIONS

I agree that my child will be held responsible for adhering to the rules and regulations of the school as published in the student handbook and any amendments made to the handbook during the school year. I agree to pay the cost of any damage to or loss of school property caused by my child. I agree to participate in a mandatory fundraiser for the school. I acknowledge the total cost of the fundraiser (\$500) is due by December 1, 2023. I agree to the school's policy that no grade reports, final grades, or transcripts of credits will be released if tuition, fee payments, or fundraising monies are outstanding beyond 30 days. I agree, jointly or severably, to pay the tuition, fees, and fundraising monies as stated above in consideration of my child's enrollment at Bulloch Academy.

### FORCE MAJEURE

The School's duties and obligations under this contract may be modified, altered or temporarily suspended without notice effective immediately during all periods that the School is impacted in its ability to deliver its educational services/products in its usual manner or on its usual schedule because of force majeure events including, but not limited to, any fire, act of God, hurricane, war, governmental action, act of terrorism, epidemic, pandemic, or any other event beyond the School's control. If such an event occurs and the School determines it will close or otherwise alter how it delivers its services, the School's duties and obligations in this Contract may be postponed, altered or delivered in an alternate format until such time as the School, in its sole discretion, determines to return to regular operations or reopen. Under these circumstances, the school reserves the sole right to decide the most suitable way to impart its curriculum whether temporarily delaying delivery of its curriculum or delivering the curriculum virtually, in a hybrid or staggered in-person format or by some other means. To be clear, as mere examples, the School retains the right under such circumstances to change school or class schedules or dates of educational delivery, add school days, provide virtual or other learning among other measures.

### ENROLLMENT CLAUSE

I understand and agree that a positive and constructive working relationship between Bulloch Academy and the parents/guardians is essential to the fulfillment of the school's educational purpose. Thus, Bulloch Academy reserves the right not to extend the privilege of enrollment to a student if the school concludes, at its sole discretion, that the actions of the parents/guardians make such a positive and constructive relationship impossible or otherwise seriously interfere with the school's accomplishment of its educational purpose. Moreover, Bulloch Academy reserves the right to dismiss the student at any time if, in the judgment of the Head of School, the conduct of anyone directly associated with the student, including, but not limited to the student's parents/guardians, in or out of the school, is not in keeping with the school's accepted standards or principles. Any unpaid balance is payable in full according to the terms of this contract. If for any reason, it is in the best interest of the school, it reserves the right to withdraw an offer of enrollment at any time and to nullify an executed contract.
